2. Attendee in person

2.1 Everyone Attendees must be examine before entering the meeting area. Anyone who fails to pass the

screening i.e. shows symptoms of fever or has a body temperature greater than 37.1 degrees, will be denial from entry. However, all the shareholders who's failed the body's exam, can still vote by proxy by assigning an independent director to vote on their behalf.
